Who we will disclose your personal data to

- Our nominated provider of official ACO merchandise who will fulfil any orders you place. We will not disclose your personal data relating to your ethnicity, DBS status, gender
- ICC Europe as your local membership body in the case of officials based outside of England and Wales but within Europe. We will not disclose your personal data relating to your gender, DBS status and ethnicity.

For bookings

Legal basis for processing your personal data

The legal basis for the collection and processing of your personal data is:

- **administration and programme delivery:** that it is necessary to fulfil the contract that you are going to enter into or have entered into with us or our merchandise provider
- **for equality and inclusion:** that you have given your explicit consent by answering the question
- **medical support:** that you have (or if you are under 13, your parent or carer has) given explicit consent by answering the question or that it is in your vital interests or the vital interests of somebody else
- **direct marketing:** (which may include profiling for the purposes of direct marketing): that you (or, if you are under 13, your parent or carer) has given consent
- **promotional activities:** that you (or, if you are under 13, your parent or carer) has given consent
- **(in all other cases):** that it is necessary for our legitimate interests which are to build a programme to encourage participation in cricket and does not prejudice or harm rights and freedoms of participants or parents/carers of children that join the programme and/or that it is necessary for the establishment, exercise or defence of legal claims.

Direct marketing

We hope you would like to hear from us from time to time by and that you will allow us to use your personal data for direct marketing and to tailor our marketing communications to suit what we think you will find interesting and relevant (profiling).

Your right to withdraw consent

Where you have (or for those under 13, your parent or carer has) given consent, you / they have the right to withdraw that consent at any time. If you or they do, it will not affect the lawfulness of any processing for which we had consent prior to it being withdrawn.

Location of your personal data

We will normally store your personal data within the United Kingdom or the European Economic Area.

We also, occasionally, may use service providers such as Survey Monkey in connection with surveys who hold relevant data in the USA in which case, it will be protected in accordance with UK data protection law.

How long we will keep your personal data for

We will keep your full name, date of birth and qualification obtained as a record of qualification for 20 years. All other personal data will be retained for 2 years after your last engagement with us. After this time period, we will anonymise the personal data we hold and keep it for analysis of participation trends.

Your rights in respect of your personal data

You have the right of access to your personal data and, in some cases, to require us to restrict, erase or rectify it or to object to our processing it, and the right of data portability.
